AFFIDAVIT

I, Marie-louise Felicia Allen, of 10136 King George Boulevard suite 1013, Surrey BC., educator, dog and horse trainer and rehabilitator for nearly fifty years, ~~SWEAR (OR AFFIRM)~~ THAT:

1. I am the self-represented plaintiff in this proceeding, and I confirm that the information in my petition and herein is true and correct to the best of my knowledge.

Background

2. I was employed for nearly fifty years operating an equine (horse) business and farm animal rescue, Epona Stable and Farms, started by my parents in 1975 on a property with acreage they had purchased in North Vancouver, BC Canada. **Attached as exhibit "1"** is information on Epona Stable and Farms (closed now).
3. I am the founder of the Standardbred Horse Fan Club run by volunteers that rescue former race horses to spare them slaughter providing veterinary care, retraining and rehoming when the horses have fully recovered from their racing career injuries and trauma. The society celebrated its 20th anniversary last year. **Attached as exhibit "2"** is information on the Standardbred Horse Fan Club.

4. I am the founder of Equine Assisted Natural Healing (EANH), the first non-riding horse therapy for children on the spectrum and youth at risk in Canada. EANH is now widely accepted and recognized under the umbrella of “animal therapy”. *Attached as exhibit “3”* is information on the non-riding therapy program.
5. I am also the founder of True Natural Horsemanship (TNH) which teaches how to humanely work with horses without the use of painful equipment, *attached as exhibit “4”* is information on TNH. I am the published author of a puppy training guide “Good Puppy!” I am the founder of the non-profit, incorporated Society For Public Guardians and Animals which represents people with pets in the province and is run by volunteers, *attached as exhibit “5”* is information on the society.
6. I am hoping to realize an extremely special project “Amity” for youth at risk and individuals with addiction, which provides healing with the help of farm animal therapy, learning a new purpose by living on, and cultivating on farm produce, learning life skills and actively practising a lifestyle without drugs as part of the rehabilitation. *Attached as exhibit “6”* is the cover page on the proposal which the provincial government has so far shown interest in.
7. Living in supportive housing with individuals struggling with addiction, I have more experience with people with addiction and their natural trust of animals than most.
8. *Attached as exhibits “7”, “8” and “9”* is media coverage/reviews of my work over the years.
9. My education consists of university, two -time college graduate and various certifications (Red Cross First Aid, etc). I do not have a criminal record and until recently, had never been charged with animal abuse until the tragedy with a little therapy miniature pony whom I had raised since a baby for eleven years. *Attached as exhibit “10”* is Bentley, the pony, as a baby and as an adult shortly before his unfortunate accident.
10. The miniature therapy pony hurt himself unexpectedly in the barn. He was placed under the care of a named equine specialist, Dr. Hermann Geertseema, DVM and an equine surgeon, Joanna Elizabeth Virgin, DVM, MS, DACVS (LA) Diplomate ACVS (Large Animal) (“veterinary team”). The pony was on a treatment plan with a documented prognosis and upcoming surgery. The prognosis by the veterinary team for recovery was “good”.

11. Briefly below are the credentials of my veterinary team:

Dr. Hermann Geertsema, DVM
Proprietor, Total Equine Veterinary Services
Equine Specialist Veterinarian

Dr. Geertsema graduated from the University of Guelph in 1994 with a doctorate degree in veterinary medicine and has practised as an equine specialist for thirty years. His practice located in Langley, B.C., *Total Equine Veterinary Services*, offers both fully mobile services as well as a fully equipped clinic with an in-house laboratory. Prior to becoming a veterinarian, Dr Geertsema was a certified horse blacksmith with a specialized interest in lameness and corrective, therapeutic shoeing. Dr. Geertsema passed away unexpectedly in October, 2023.

Dr. Joanna Elizabeth Virgin, DVM, MS, DACVS (LA) Diplomate ACVS (Large Animal)
Veterinary Surgeon

Dr. Joanna Virgin is a board certified veterinary surgeon and a specialist in equines (Diplomate ACVS in large animals). Dr. Virgin is licensed to practice in British Columbia by the College of Veterinarians in British Columbia and as a veterinary surgeon who is board-certified by the American College Of Veterinary Surgeons since 2011. A veterinary surgeon who is board-certified by the American College Of Veterinary Surgeons has undergone extensive additional training after veterinary school in order to become a specialist. Dr. Virgin is highly regarded for her equine knowledge and treatment experience.

12. The BC SPCA became involved through a complaint. The BC SPCA constable went to my barn and saw the pony whom she did not find to be in distress, her notes from the visit ***are attached as exhibit “11”***.
13. The next day the BC SPCA brought in a non-treating veterinarian to assess the pony. The pony was seized and euthanized without consultation with my treating veterinary team. Neither of my veterinary team had complained about me. Neither knew of the complaint submitted to the BC SPCA.
14. At the time of the pony’s seizure I was provided with a Notice Of Disposition by the BC SPCA constable outlining the review and appeal processes. I requested a review and appeal which failed because the pony had been destroyed.
15. I was then charged and convicted as a self-represented litigant under *section 24(1)* of the Prevention Of Cruelty To Animals Act. *Legal Aid* had promised a solicitor, however eight


weeks before the trial started that was retracted. Crown seeks sentencing which includes “a ban on owning animals.”

16. The expenses for veterinary treatment and special care provisions for the duration of treatment of the pony was close to \$5,000. If the BC SPCA had not seized the pony he would be alive today.
17. I was crushed, in shock and went into a deep depression at the loss of the pony. The loss of the little pony whom I had raised since childhood was too much to bear.
18. I was eventually apprehended under the Mental Health Act by the RCMP and released the same day. The BC SPCA had in the interval removed my other therapy horses from the barn. I felt that my life was over.
19. Under the care of a psychiatrist, I was diagnosed with a resulting depressive disorder. I have been living on a provincial Disability benefit since in supportive housing. Attached is the letter from the provincial government confirming my Disability standing *as exhibit “12”*.
20. There is an existing claim in the BC Supreme court which I filed in 2023 with the BC SPCA named as defendant for the return of my therapy horses since it is alleged that they were seized unlawfully.
21. I am trying to rebuild my life. I am trying to restore my livelihood.
22. *Attached as exhibit “13”* is Dr. Monica Marcu’s affidavit. Her German Shepherd dog scheduled for surgery was seized by the BC SPCA at *para 5 and 6*.
23. I will rely on case law where others with animals in veterinary treatment have had their animals seized.

She took up horse rescue as a sideline several years ago and founded the fan club to support the program and raise funds. Many of the horses would likely end up in the slaughterhouse and be sold for horse meat without intervention, she said.

AFFIDAVIT

I, Dr Monica Marcu, RN, PharmD, PhD, of Redmond, USA, and McBride, BC, Canada, of profession medical/health care provider and scientist, SWEAR THAT:

1. I have over 45 years of medicine expertise, two doctoral degrees and have performed many medical duties and cared for hundreds of patients, students, in various medical venues. I also have excellent expertise in veterinary medicine and over 30 years of work with German Shepherd Dogs (GSDs) – care, training, breeding, healing and more. I am internationally recognized as a specialist in nutrition and disease prevention with nutrition.
2. We had a passion and hobby and loved GSDs and we have brought them to our large farm, 155 acres in McBride BC, so they can live naturally as shepherds and farm dogs- as they were meant to live as breed. We offered them outstanding conditions of space, medical and professional care, mostly fresh home-made food, multiple opportunities for socializing, play, run and more. Our dogs were mostly free within the fenced property.
3. In the morning of July 30th 2024, unexpectedly and violently, BC SPCA supported by the local RCMP have trespassed our property and farm and ultimately have stolen ALL our beloved GSDs - our family members, including the most seniors and my medical service dog – over 12 y old. Some of these dogs were treated by me for minor problems such as wounds, scratches, diarrhea, ongoing deworming, prenatal and puppy care, joint and arthritis support – a third of my GSDs were senior over 8 y of age (8-13 y). These senior GSDs were in great condition, very active, none had cancers, immune problems, or handicaps. They all could run and play energetically.
4. All these dogs were under my care and medical supervision, but when there was a more serious health problem such as surgeries, we took our dogs to Jasper, AB, vet clinic to Dr Janet Jones. They know us for about 10 years. Our closest functional veterinary clinic was 2 h away, in Jasper, AB.
5. A senior (13 y old) GSD was scheduled for a minor **surgery for 31 July** in Jasper, after her surgery was postponed twice due to the huge fires in Jasper and ongoing evacuations. We also were under the threat of evacuation due to a close by fire. Another GSD was waiting for a special vet consultation

and an intervention I could not do, but he was not that serious, and priority was given to other customers due to very scarce resources available at the Jasper clinic that time.

6. BC SPCA have forcibly removed my senior beloved GSD, *despite her being scheduled next day for surgery* and later claimed that I was not caring for her (and other dogs). This was simply NOT true, just like most BC SPCA false allegations about our care, living conditions, and dogs overall. None of our beloved GSDs were neglected, ever, all medical needs were met by me or our vets in Canada or USA.
7. The theft of our beloved GSDs, especially the seniors who were probably murdered by BC SPCA was extremely traumatic for me and my family. These dogs lived with us all their long lives very well, most were born in my hands, and we have invested tens of hours of work and hundreds of thousands of dollars in their care, training, registrations, travels, etc. BC SPCA never offered any transparency or news about my beloved children!
8. I have asked for an independent vet to be allowed to observe the status of my dogs (as it is allowed in USA, reasonably) BUT I was refused. Any of my demands to see, observe, assist or get news about my dogs – especially that some were starting to die at the pound- were totally refused by BC SPCA.
9. BC SPCA also removed another senior (but healthy and active) GSD, my *medical service dog*, who had a small hotspot on a back leg. He was under my care successfully. The theft of a medical service dog is a high crime in most civilized countries and it is not allowed even in case of criminals. But I was deprived of his vital presence, and left completely alone, without any protection on a property in the middle of the forest - kilometers from closest neighbor.
10. After 5 months this service senior dog was returned to me after I paid thousands of dollars for *teeth extraction* that was enforced by BC SPCA - I picked him up from Chilliwack BC SPCA site. I went there with a witness so he can also observe the condition of my beloved GSD. We were shocked to see my dog's condition: he was badly limping, overweight but with serious hind sarcopenia (loss of muscle mass), he defecated twice and peed three times within the first 10 min. of walking him outside of the BC SPCA facility. He was in a small cage, sitting on a cold cement floor when I picked him, very detrimental to his joints. At home, he refused to eat anything but very soft foods, and only served by hand, as he was in serious

pain after the dental procedures I was forced to pay in order to retrieve him from BC SPCA.

11. It took me more than 4 months to improve the very poor health condition of this senior dog, but I was able to help him gain back lost muscle, eat normally and completely remove his limping. He now walks normally and is very active, multiple witnesses have seen his *miraculous recovery* under my medical care.
12. The theft of our GSDs and the multiple illegalities (trespasses without any warrant, endangering my life for hours, obstruction of justice and refusal of witnesses, vandalism, and others) perpetrated by BC SPCA and local RCMP are under investigation and more actions will follow.
13. I have never seen again my senior 13 y old GSD who was scheduled for surgery. I took care of her for 13 years and she was much beloved in my family. Other than the small neck wound, she had no other noticeable health problems, and she was very powerful and active at the time BC SPCA stole her.

I declare under penalty of perjury (28 U.S. Code § 1746) that the foregoing is true and correct.
